B.B.A. and BCA graduation programmes from the academic year 2020-  
21, following the guidelines as per under Section 59 (11) of the  
Karnataka State Universities Act, 2000 as per Ref. (1), application  
from the college seeking the recommendation of the Government, the  
report of the local inquiry committee and the specifications of the  
syndicate / academics councils has been closely reviewed along with  
other documents as per ref.(2).



I am hereby directed to inform that the Karnataka State Universities Act is enacted in accordance with Sec. 59 (11) of the Karnataka State Universities Act, 2000, as per the report submitted by the Local Inquiry Committee, the Regulation of Quantitative Parameters and the availability of academic / physical and civic infrastructure in accordance with the provisions of reference (1) for the incorporation of various combination courses at **United International Degree College** located on Hennur-Bagalur Main Road, HennurPost, Opp. Farana Nursing College, Bangalore-49 from the academic year 2020-21 as detailed below for B.A., B.Com., B.B.A. and B.C.A. degree courses.

B.A.	History, Economics, Optional English	80 (eighty)
B.A.	Sociology, History, Psychology	80 (eighty)
B.A.	Journalism, Political Science, Sociology,	80 (eighty)
B.B.A.	As per university's regulations	60 (sixty)
B.Com.	As per university's regulations	80 (eighty)
B.C.A.	As per university's regulations	40 (forty)

The addition of new combinations at the United International Degree College from the academic year 2020-21 is subject to the terms of the new combination, including the terms of the Local Inquiry Committee.

1. Although there are provisions in the grant code applicable to colleges, the government does not grant any grants to the above courses. It should be considered as a permanent unaided course.
2. The college shall obey and follow university code of conduct without fail.
3. Shall not admit more than the prescribed number of students



4. Shall strictly adhere and follow the existing Government Regulations, Directives and University code of conduct etc., and every condition imposed thereupon.
5. Must strictly follow the conditions laid by the local inquiry committee
6. The college / governing body shall set a university quota of 50% (where applicable) and shall collect only the fees fixed by the university from time to time, not exceeding the fee set by the university;
7. As per the orders passed by the Supreme Court in case of Visakhav / s Rajasthan Government on 13-8-1997, any student who commits a riot or sexually harassing a woman in college is considered a cognizable offense, and admission of such a person / student engaged in such activities shall be cancelled and suitable action as per law against such a person / student shall be taken. Further, College / Administrative Authority shall create a Complaint Committee; and necessary action to avoid such activities shall be taken.
8. A good course should be developed for the growth of college students, and the Principal / Administrative Authority shall treat student / teaching faculty in a friendly manner.
9. College's Administrative Authority shall not unnecessarily withhold Marks card or other documents of any student until the student's admission by the University or for a period not more than six months, which ever is earlier.
10. If any student intends for a Transfer Certificate, College's Administrative Authority shall issue the same without bothering the student; And shall not receive any other amount other than tuition fee only for the remaining academic year / semester



11. Shall not receive capitation fee in any manner.
12. Shall strictly follow Roaster method for admission process.
